## **TERMS AND CONDITIONS**

Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

- The promoter of the competition is the St George Illawarra Rugby League Football Club Pty Ltd ABN 74 085 008 340, 124 Princes Hwy Kogarah, NSW, 2217 ('St George Illawarra Dragons').
- 2. Directors, management and employees of the Promoter and their immediate families are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 3. This is a game of skill. Chance plays no part in determining the winner. Each entry will be individually judged, based upon individual creative merit. All entries must be an independent creation by the entrant and free of any claims that they infringe any third party rights. Entries must not have been published previously and/or have been used to win prizes in any other competitions.

- 5. To be eligible to enter individuals must be
  - a. A 2019 Red V Member OR a current Junior Rugby League player.

  - a. Complete the entry form on dragons.com.au, including their Red V Number OR Junior League player number
  - b. Send their audition video to St George-Illawarra Dragons via Facebook Messenger.
- 7. Multiple entries are not permitted. The limit for entries is set at one (1) per individual.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 9. Incomplete, indecipherable, inaudible, or illegible applications will be deemed invalid.

- 10. The St George Illawarra Dragons abide by the Privacy Act 1998 at all times. The St George Illawarra Dragons will not misuse or change your information without your knowledge. We will not share your information with anyone who doesn't have authority to see your information.
- 11. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 12. Two winners will be selected at the Promoter's premises on Monday 4 February 2019. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winners will be notified by telephone and/or email on the day of the draw.
- 13. The Promoter's decision is final and no correspondence will be entered into.
- 14. The winners will be eligible to participate in interviews with part of the 2019 St George Illawarra Dragons squad on a specified date. The prize can only be redeemed on the date specified for the interviews. The winners will need to be available on the specified date and time for the interviews and it is their responsibility to get to and from the location shoot.
